Creative Children Preschool & Kindergarten is licensed by the state of California. We are open to all children ages 2 years through 6 years regardless of race, nationality, or creed who may benefit from our program.

**Program:** We provide an age appropriate, creative, and developmental program with an academic curriculum based on individual needs, in a loving, gentle, safe, and nurturing environment. Our educational program promotes intellectual development in the areas of language, reading, math, and science. Social development, creative arts, music, and physical development are promoted as well for our balanced program.

Family discount: 10% sibling discount on second and third child.

**Yearly Enrollment Fee: \$200-NON-REFUNDABLE** 

**Book Fee: \$100 (for Junior Kindergarten & Kindergarten Students Only) NON-REFUNDABLE** 

Late Pick-up Fees: School closes promptly at 6:00 PM. There is a charge of \$1.00 per minute after 6:00 PM to be paid directly to the teachers.

Late Pick-up Fee of \$5.00/hour will be charged if the child is not picked up within 15 minutes of their destined pick-up time (either 12:00 PM or 3:00 PM). After 6 pm \$1 a per minute fee.

**Payment:** The school year tuition August through June is based on a 4-week period and needs to be pre-paid. A late fee of \$25 will be added if payment is not received within 7 days after the due date. A penalty of \$25 will be charged for each returned check.

Any account that is past due is subject to admittance being denied and possible collection procedures. No credit or make up days are allowed for absences, personal vacations, teacher preparation days, or school holidays. See the school calendar for holidays listed.



## **TERMINATION POLICY**

The preschool may exclude or terminate the enrollment of your child in the school program immediately upon written notice to the parent of such exclusion and termination if any of the following conditions occur:

- If the behavior of the child or his/her parent(s) or guardian(s) threatens the physical wellbeing, mental health, or safety of one or more of the children or persons at the Preschool (inappropriate, unwelcome, or offensive conduct, whether verbal, visual, or physical).
- Any parent or guardian who in any way interferes with or prevents a faculty member from carrying out his/her duties in a satisfactory manner will be required to leave the Preschool premises immediately. If the parent or guardian refuses to leave, the Preschool staff will seek assistance, if necessary, from civil authorities.
- Termination can result from failure on the part of the parent to pay tuition on time.
- Termination can result from failure to comply with the policies within this contract, and the Enrollment/Financial Agreement and in our parent handbook.
- The staff can do all they can to meet the individual needs of each child, however, if it becomes evident that our program is not meeting a child's needs, we reserve the right to terminate this contract.

## **WAIVER POLICY:**

No right under the agreement shall be waived (lost) merely by delaying or failing to exercise it.

No waiver of any right under this agreement shall constitute a subsequent waiver of that right.
